INSTRUMENT RENTAL CONTRACT

1. Deposit is equal to three months hire. Rent is payable for a period of three months in advance. Payment of rent must be made strictly by due date and failure to adhere to this will incur an additional fee.
2. One months notice, in writing, must be given of intention to cease hiring the instrument. If hirer fails to give notice, deposit will be forfeited. Lander's Music reserves the right to cancel the contract with one months notice, in writing.
3. All repairs and maintenance are the hirer's responsibility (except manufacturer's faults). Repairs must be carried out by Lander's Music.
4. A decision to purchase the instrument may be made within the first nine months of hire. If the goods are purchased within nine (9) months of agreement date all rental and deposit money paid will be deducted from the purchase price.

**NOTE: Rental payments after the first nine months will not be deducted from the purchase price.**

5. This contract is for rental of the instrument only and the instrument shall remain the property of Lander's Music. Any decision by hirer to purchase the instrument from Lander's Music must be made as a separate contract and is in no way contained to this agreement.
